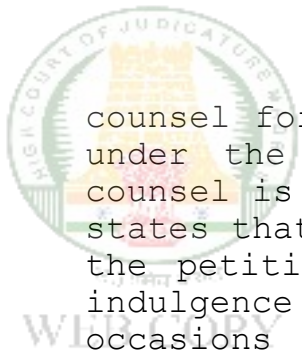

ORDER

When the writ petition was posted on 02.01.2020, there was no representation for the petitioner. Hence, registry was directed to post the matter on 03.01.2020.
