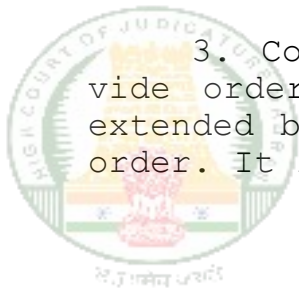
Prayer in CRL OP(MD). 22545/ 2016 :
