2.Hence, the Criminal Original Petition is dismissed.

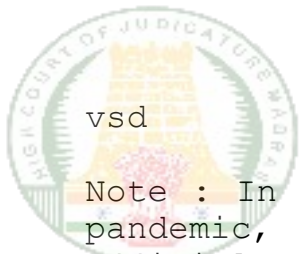
