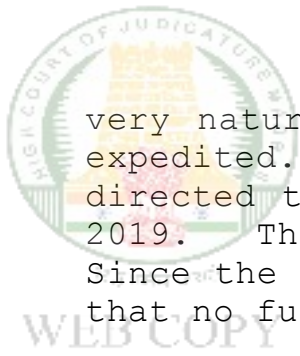

The third respondent also caused damage to the petitioner's property.

2.The learned Government Advocate states that final report has been filed against the third respondent and states that the case is presently pending in PRC.No.358 of 2019 on the file of the learned Judicial Magistrate No.V, Madurai.
