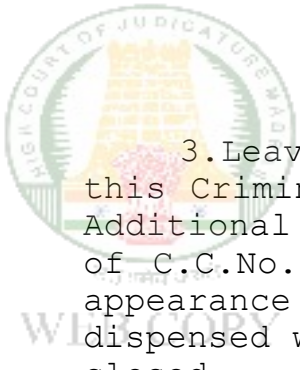

The petitioners are facing trial in C.C.No.157 of 2016 on the file Judicial Magistrate No.1, Karur, have now transferred to Additional Mahila Court, Karur and renumbered as C.C.No.4 of 2020 for matrimonial offences.

2.The learned Government Advocate pointed out that the trial in this case has already commenced. Therefore, the question of exercising the inherent powers of this Court does not arise.

However, the learned Additional Mahila Court, Karur is directed to expedite the disposal of C.C.No.4 of 2020 within a period of two months.
