ORDER

Court and filed a status report, in which, it has been stated that A1 is the Company, A2 is the Managing Director, who is no more, A3 is the wife of A2 and A4 is the brother of A2. A3 was arrested on 12.12.2019 and A4 was arrested on 16.12.2019. The contemnor would submit that sofar 13 properties worth Rs. 1 crore have been identified and they are taking steps to attach 25 properties belonging to A2 and steps are taking through revenue authorities, and the order has been complied with.
