Prayer in CMP(MD) No.12165 of 2018:-

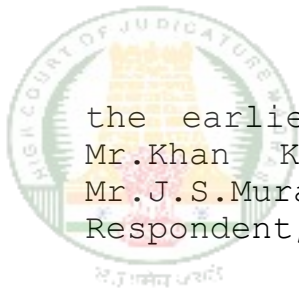
