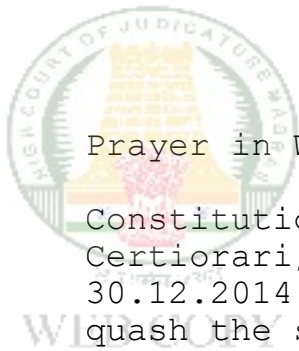

PRAYER IN CMP(MD)9604 OF 2019 in WA(MD).No.53 of 2019:

Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to fix an early date to hear the main WA(MD)No.53/2019 and thus render justice.

PRAYER IN WA(MD)No.53/2019:

To set aside the order passed in WP(MD).No.6396 of 2015 dated 06.06.2018 and allow this writ appeal to confirm the award with respect to the Issue No.3 and 2 partly and set aside the award with respect to Issue No.1,4 and Issue No.2 partly passed in I.D.No.670/1989 dated 30.12.2014 in the interest of justice.



Prayer in WP(MD). 6396/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari, to call for the records pertaining to the award dated 30.12.2014 passed by the 1st Respondent in I.D. No. 670/1989 and quash the same.

PRAYER IN CMP(MD)9606 OF 2019 in WA(MD).No.54 of 2019:

Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to fix an early date to hear the main WA(MD)No.54/2019 and thus render justice.

PRAYER IN WA(MD)No.54/2019:

To set aside the order passed in WP(MD).No.3422 of 2018 dated 06.06.2018 and allow this writ appeal to confirm the award with respect to the Issue No.3 and 2 partly and set aside the award with respect to Issue No.1,4 and Issue No.2 partly passed in I.D.No.670/1989 dated 30.12.2014 in the interest of justice.

Prayer in WP(MD). 3422/ 2018 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorari calling for the records relating to the impugned award dated 30/12/2014 passed by the 1st respondent in I.D.No.670/1989 and quash the same as illegal insofar as it related to its finding that the charges leveled against the 2nd respondent were not provedant .
