2.The learned Special Government Pleader appearing for the respondents, on instructions, would submit that the respondents has



considered the petitioner's request and allotted an alternative place to the petitioner's association for parking maxi cab. The petitioner has also accepted the said proposal of the respondent. Therefore, nothing survives for further adjudication.

3. Recording the said submission made by the learned Special Government Pleader appearing for the respondents, this Writ Petition is dismissed as infructuous. No costs. Consequently, connected miscellaneous petition is closed.
