2. Heard the learned counsel appearing for the petitioner as well as the learned Special Government Pleader appearing for the respondents.

3. It is represented that the Trustee is no more now. This Court is not inclined to go into those aspect as to whether his son could be appointed as a Trustee or not. The relief sought for by the petitioner is restricted to the year 2018. Therefore, this Writ Petition stands dismissed as abated. No Costs. Consequently, connected miscellaneous petition is closed
