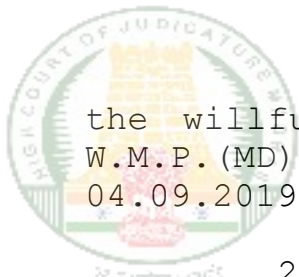
Prayer in WP(MD). 19238/ 2019 :
