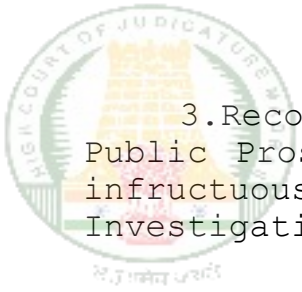

2.Today, when the petition is came up for hearing, the learned Additional Public Prosecutor appearing for the respondents 1 to 4, on instructions, would submit that in the above referred case, the fourth respondent herein completed the investigation and after serving R.C.S notice to the defacto complainant, he filed a final report before the learned Jurisdictional Magistrate on 11.12.2018 itself.



3.Recording the submission made by the learned Additional Public Prosecutor, this Criminal Original Petition is dismissed as infructuous with liberty to the petitioner to approach the Investigation Officer for further investigation.
