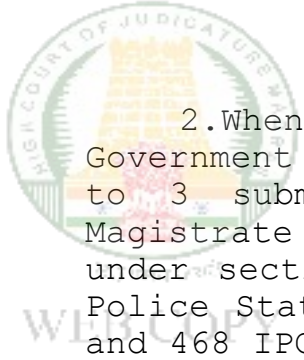

When the matter is taken up for hearing, the learned Government Advocate (Criminal side) appearing for the respondents 1 to 3 submitted that based on the direction of the Judicial Magistrate No.II, Kovilpatti on the petition filed by the petitioner under section 156(3) Cr.P.C, a case was registered at Ettayapuram Police Station in Crime No.31 of 2014 under sections 423, 420, 465 and 468 IPC and on enquiry, the petition given by the petitioner was closed as "Action Dropped" by 2nd respondent, on 21.05.2018 and he has also filed the copy of the report to that effect.
