ORDER

3.In the result, the Criminal Original Petition is dismissed. Consequently connected miscellaneous petition is closed. However, the petitioner is at liberty to challenge the final report in the manner known to law.

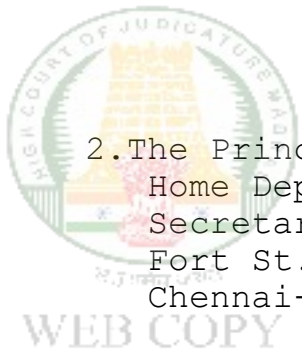
