Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Directing the 2nd and 3rd respondents to grant an alternate employment to the petitioner as per section 20 of the Rights of Persons with Disabilities Act, 2016 based on the medical report of the 4th respondent to be submitted based on the assessment conducted on the petitioner on 2.5.2019 and consequently direct the respondent to grant backwages, continuity of service, service weightage review for the period of absences falling from 10.7.2019 till the grant of alternative employment is made by the respondents.

To pass an order of ad interim injunction restraining the respondents No.2 and 3 from transferring the petitioner from the Wheel Maintenance Section in the alternative employment to regular employment, pending disposal of the above WP and thus render justice.
