PRAYER: Contempt Petition is filed under Section 11 of Contempt of Courts Act, to punish the contemnors/respondents for the willful disobedience of the order dated 03.06.2019 passed in W.P(MD)No.806 of 2013 by this Court.

Prayer in WP(MD). 806 of 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue Writ of Certiorarified Mandamus calling for the records relating to the proceedings of the impugned order in Na.ka.No.150/2010 dated 27.08.10 on the file of the 3rd Respondent and quash the same and further directing the 3rd Respondent to 5% special pay recovered by the 3rd Respondent for the period 01.09.1998 to 31.12.2006 and further revising the salary of the Petitioner by considering the 5% special pay and to pay the arrears accrued and further directing 3rd Respondent to pay the interest on the Provident Fund disbursed to the Petitioner.

He has also produced copies of the same.

3.Recording the same, the contempt petition is closed. Consequently, connected Sub.A(MD)No.40 of 2020 is also closed.
