PRAYER IN CRL RC(MD)SR.No.36115 of 2019:

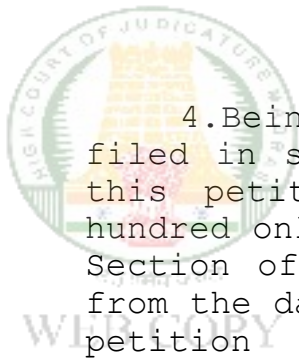
