2. The petitioners apprehending arrest at the hands of the
respondent police for the offence punishable under section 498(A) of

3.The petitioner's counsel stated that the matter can be resolved through Mediation. The matter was referred to Mediation.

6.Therefore, I am of the view that in the event of the first respondent registering an FIR, the first respondent shall intimate the petitioners herein about the registration of the FIR and give breathing time to the petitioners herein to move this Court for the relief of anticipatory bail. This direction is given, since this petition has not been adjudicated on merits.

7.With this direction to the first respondent, this criminal original petition is disposed of.
