PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Certiorarified Mandamus, relating to the Notification issued by the 2nd respondent in his proceedings in Advertisement No.562, Notification No.32/2019 dated 18.11.2019 insofar as Clause 4(B)(b) is concerned and to quash the same is illegal and consequentially to direct the 1st respondent to grant exemption to the petitioner who studied S.S.L.C./H.S.C. Without Tamil as one of the language by taking into consideration of pass in Second Class Language Test (Full Test) in Tamil conducted by the 2nd respondent in terms of Section 21(1) of the Tamil Nadu Government Servants (Conditions of Service) Act 2016.
