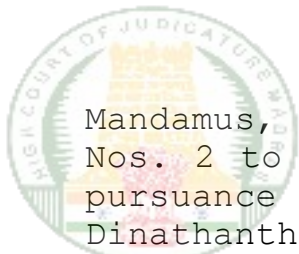
PRAYER: Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971 to punish the respondents for the deliberate and willful disobedience of the order passed by this Court in W.M.P.(MD).No.18650 of 2017 in W.P.(MD).No.22345 of 2017 dated 14.12.2017.

Prayer in WMP(MD)No.18650 of 2017:

To grant an Ad Interim Injunction restraining the respondents from awarding the bid to any other third parties pending disposal of the above writ petition.

Prayer in WP(MD). 22345 of 2017 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of



Mandamus, directing the tender committee comprising of respondent Nos. 2 to 4 to declare the petitioner as the successful bidder in pursuance of the Lorry Freight Tender Notification published in Dinathanthi Daily dated 08.11.17 for the movement of essential commodities to the 218 fair price shops situated in Vilavancode Taluk for the period from 01.12.17 to 30.11.19 and consequently direct the 4th respondent to issue Contract Appointment order in the petitioners favour within the period that may be stipulated by this Honble Court.

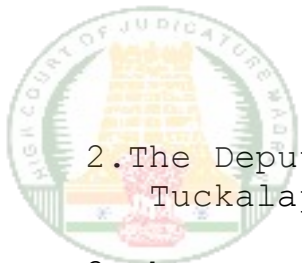
