Prayer in WP(MD).No.18688 of 2017 :

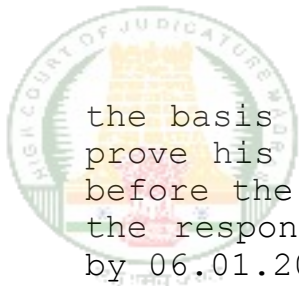

ORDER:-

Contempt Petition coming up for hearing on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr. H.Velavadhas, Advocate for the Petitioner and of Mr. A.Muthukaruppan, Additional Government Pleader on behalf of the respondent, this Court made the following order:

The petitioner's application appears to have been rejected originally on the ground that he is not even a member of the society and not entitled to the crop insurance. However, later, on the representation of the petitioner, the Deputy Director of Agriculture
