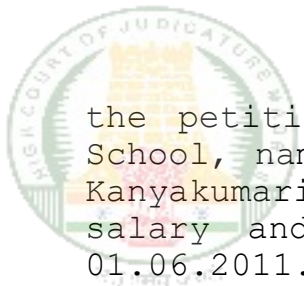
Prayer in WA(MD).151/2018:
