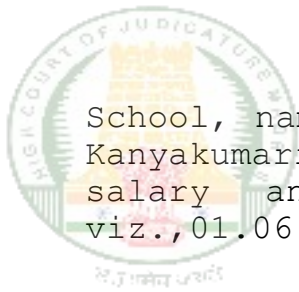
Prayer in WA(MD).149/2018:
