PRAYER :-

ORDER : The Court made the following order :-

The petitioners apprehending arrest at the hands of the
respondent police for the offences punishable under Section 420 of
I.P.C, in Crime No.Not known of 2019, seek anticipatory bail.

the learned Government Advocate (Crl. Side) appearing for the
respondent.

3.When the matter was taken up for hearing, the learned
Government Advocate (Crl. Side) for the respondent states that the
primary allegations have been made only against A-1, who is son of
the petitioners herein. He is said to be absconding. Only after
his arrest, the involvement of the petitioners will be known. No FIR
has been registered as on date. He further states that if any FIR
is registered and there is a proposal to arrest the petitioners



herein, they will be put on notice before the proceeding further. This arrangement is directed so as to give breathing time to the petitioners to move this Court for the relief.

4. Recording the said submission of the learned Government Advocate (Crl. side), this Criminal Original Petition stands disposed of.
