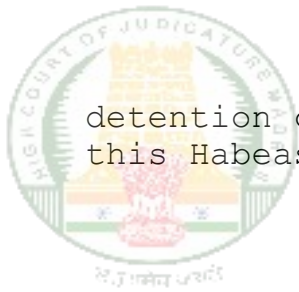
PRAYER: Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Habeas Corpus, calling for the entire records connected with the detention order of the second respondent in C.No.35/Detention/C.P.O/T.C/2019, dated 10.12.2019, quash the same and direct the respondents to produce the body or person of the detenu, by name Vairamani, son of Selvam (Detaining authority wrongly mentioned as Selvaraj), aged about 19 years, now confined as 'Goonda' at Trichy Central Prison before this Court and set him at liberty forthwith.
