The fifth respondent after completion of investigation in Crime No.1076 of 2017 and filed a final report and the same has been taken cognizance in C.C.No.252 of 2019 for the offence under Sections 8(c) r/w 20(b)(ii) of NDPS Act, on the file of the Special Court, Madurai and it is pending for trial. While being so, only to escape from the clutches of law, this Writ Petition has been filed.

3.Admittedly, the petitioner is attempted to escape form the clutches of crime committed by her. Hence, the Writ Petition cannot be entertained and the same has to be dismissed.
