2.This Writ Petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petition is closed.

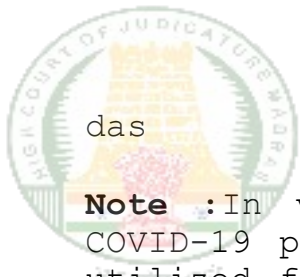
