Transfer Criminal Petition No.122 of 2017

ORDER:

This Transfer Criminal Petition is filed seeking to transfer CC No.710 of 2015 from the Court of the XIX Metropolitan Magistrate, Cyberabad, Kukatpally at Miyapur to any competent Court at Criminal Courts Complex, Nampally, Hyderabad.

Today, the matter is listed under the caption 'infructuous matters' and when the matter is taken up for hearing, the learned Additional Public Prosecutor, based on the e-courts case status report, would submit that the matter was disposed of, by order dated 05.09.2018 of the XIX Metropolitan Magistrate, Cyberabad, Kukatpally at Miyapur, and as such, the present transfer criminal petition filed does not require further consideration by this Court.

Having regard to the submissions made as above, no further orders need be passed in the present transfer criminal petition. Accordingly, the transfer criminal petition is closed. However, the petitioner is at liberty to file a petition seeking to reopen the matter, in the event the said CC has not been disposed of by the trial Court as noted above.

Miscellaneous petitions, if any, pending in this criminal petition shall stand closed.
