Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents to forthwith appoint the petitioner to the post of Junior Panchayat Secretary in Karimnagar District against BC(B) General vacancy as per the selection at Sl. No. 24 of the merit list of Karimnagar District in terms of the residential order vide GO Ms No. 24 GAD (SPF-MC) Dept. dt. 30.8.2018 and GO Ms No. 56 Panchayat Raj and Rural Development PPTS.VI Department, dated 22.10.2019, pending disposal of WP No. 9041 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

"The petitioner has appeared for the post of Junior Panchayat Secretary. As he has studied all through his career in composite District of Karimnagar, he is claiming local status in respect of Karimnagar, but the respondents are not treating him as a local candidate of Karimnagar and not considering his case for the said post on the ground that he has studied in Warangal Urban District.

Since the petitioner has studied in the composite District of Karimnagar, he has to be treated as a local candidate of Karimnagar. Therefore, the respondents are directed to consider the case of the petitioner for appointment to the post of Junior Panchayat

Secretary by treating him as a local candidate of Karimnagar, irrespective of the fact that he has studied in Warangal Urban District, in the existing vacancies."
