Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the case of the petitioner for appointment to the post of Junior Panchayat Secretary against BC-B vacancy in Karimnagar District in terms of G.O.Ms.No. 56, Panchayat Raj and Rural Development Department, dated 22-10-2019 by considering the representation submitted by the petitioner, pending disposal of WP No. 11940 of 2020, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

The petitioner has appeared for the post of Junior Panchayat Secretary. As she has studied all through her career in composite District of Karimnagar, she is claiming local status in respect of Karimnagar, but the respondents are not treating her as a local candidate of Karimnagar and not considering her case for the said post on the ground that she has studied in Warangal Urban District.

Since the petitioner has studied in the composite District of Karimnagar, she has to be treated as a local candidate of Karimnagar. Therefore, the respondents are directed to consider the case of the petitioner for appointment to the post of Junior Panchayat Secretary by treating her as a local candidate of Karimnagar, irrespective of the fact that she has studied in Warangal Urban District, in the existing vacancies.
