The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and the order of the High Court dated 03.09.2020, 11.09.2020 made in CrI.P., and upon hearing the arguments of Sri Shaik Karimulla Advocate for the Petitioner and of Public Prosecutor for the Respondent, the Court made the following

ORDER

This petition is filed under Section 439(1)(b) Cr.P.C., seeking relaxation of the conditions imposed in the order dated 11.09.2020 passed in CrI.P.No.3695 of 2020, wherein this Court while releasing the petitioner on anticipatory bail imposed a condition that he should report before the investigating officer on every Sunday between 10.00 a.m. and 05.00 p.m. till filing of the charge sheet.

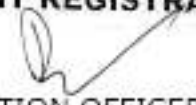
The counsel for the petitioner mainly submits that the petitioner has been complying with the said condition from the date of his release, which fact is not disputed by the learned Public Prosecutor.

Having regard to the facts and circumstances of the case, the condition imposed on petitioner to report before the Station House Officer, Adilabad I-Town Police Station, Adilabad District on every Sunday between 10.00 a.m. and 05.00 p.m. is hereby relaxed. However, petitioner shall report before the aforesaid Station House Officer, on the Third Sunday of every month between 10.00 a.m. and 05.00 p.m. till the completion of investigation and filing of charge sheet.

Accordingly, the I.A. is ordered.
