Petition under Section 482 of Cr.P.C., praying that in the circumstances stated in the petition, the High Court may be pleased to relax the condition, imposed in CrI.P.No.3960/2020, dated 15/09/2020, directing the petitioner to report before the SHO, Gachibowli Women Police Station, Cyberabad on every Sunday.

CRLP.No.3960 of 2020

Petition under Sections 437 & 439 of Cr.P.C, praying that in the circumstances stated in the petition and the grounds filed therein, the High Court may be pleased to release the Petitioner/Accused herein on bail in FIR No.64 of 2020 of Gachibowli Women Police Station, Cyberabad, Ranga Reddy District, pending enquiry and trial;

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and the order of the High Court dated 15.09.2020 made in CrI.P. and upon hearing the arguments of Sri T.Nagarjuna Reddy, Advocate for the Petitioner, and of the Public Prosecutor, for the Respondent, the Court made the following

ORDER

This application is filed seeking to relax the condition imposed in the order dated 15.09.2020 passed by this Court in CrI.P.No.3960 of 2020, directing the petitioner to report before the Station House Officer, Gachibowli Women Police Station, Cyberabad, every Sunday between 10.00 a.m. and 5.00 p.m. till completion of investigation and filing of cahrgesheet, whichever is earlier.

Heard and perused the order dated 15.09.2020.

This Court vide order dated 15.09.2020 in CrI.P.No.3960 of 2020 granted regular bail to the petitioner/sole accused imposing certain conditions including the condition that the petitioner herein shall appear before the Station House Officer, Gachibowli Women Police Station, Cyberabad every Sunday between 10.00 a.m. and 5.00 p.m. till completion of investigation and filing of charge sheet, whichever is earlier.

Learned counsel for the petitioner would submit that the petitioner herein has been complying with the said condition by appearing before the Station House Officer concerned and cooperating with the Investigating

Officer. There is no allegation against the petitioner herein with regard to the violation of any of the conditions imposed by this Court vide order dated 15.09.2020 in CrI.P.No.3960 of 2020 and also there is no allegation against the petitioner herein that he is threatening the witnesses and not cooperating with the Investigating Officer.

On instructions, learned Public Prosecutor would submit that the Investigating Officer has recorded the statements of most of the material witnesses and charge sheet has to be filed.

Considering the said aspects, this application is allowed modifying the condition in the order dated 15.09.2020, which is as follows:-

The petitioner shall appear before the Station House Officer concerned, as and when his presence is required.
