Petition under Section 439 (1) (B), 482 Cr.P.C. praying that in the circumstances stated in the petition, the High Court may be pleased to relax the condition No.2 that the petitioners shall appear before the Station House Officer, NTPC, Ramagundem District on every day between 10.00 AM and 5.00 till the completion of the investigation as directed order dated 06-10.2020.

CRLP.NO.4533 OF 2020

Petition under Sections 437 & 439 of Cr.P.C. praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to grant Bail to the petitioners by directing their release in Crime No 161 of 2020 of police station N.T.P.C Ramagundam District, on such terms and conditions as this Hon'ble court deems fit and proper in the interest of justice.

The petition coming on for hearing, upon perusing the Petition and order of the High Court dated 6.10.2020 and upon hearing the arguments of MR.K.SURENDER Advocate for the Petitioner and PUBLIC PROSECUTOR for Respondent, the Court made the following.

ORDER

This application is filed seeking to relax the condition No.2 imposed by this Court in the order dated 06.10.2020 in Crl.P.No.4533 of 2020.

The petitioners are accused Nos.1 and 3 in Crime No. 161 of 2020 pending on the file of Station House Officer, NTPC, Ramagundem District. The offences alleged against the petitioners herein are under Sections 306 read with 34 of IPC.

This Court vide order dated 06.10.2020 granted regular bail to the petitioners herein on certain conditions including the condition of petitioners appear before the Station House Officer concerned on every day between 10.00 AM and 5.00 PM till completion of investigation and filing of charge sheet.

Now the learned counsel for the petitioners would submit that the petitioners have been complying with the orders of this Court and there are no allegations of violation of any of the conditions imposed by this Court.

On instructions, learned Public Prosecutor, would submit that the investigation is pending and statements of some witnesses have to be recorded.

Considering the above, this application is ordered modifying the said condition imposed by this Court vide order dated 06.10.2020 in CrI.P.No.4533 of 2020 that the petitioners to appear before the Station House Officer, NTPC, Ramagundam District on 1st Sunday of every month between 10.00 AM and 05.00 PM till completion of investigation and filing of charge sheet. However, it is made clear that other conditions imposed by this Court in CrI.P.No.4533 of 2020 shall remain unaltered. The petitioners shall co-operate with the Investigating Officer by appearing before him as and when their presence is required.
