Application Under Section 481 of the Companies Act, 1956 Read with
Rule 281, 282 & 9 of the Companies (Court) Rules, 1959 for dissolution of
the Company praying that this Hon'ble Court may be pleased to

- i) dispense with the service of notice on the Respondents, herein as
Official Liquidator has already ' No. Objection Certificate' from the
Respondent, above
- ii) form an opinion that the Liquidator cannot proceed with the winding
up and that it is just and reasonable in the circumstances of the case
to order for the dissolution of the company
- iii) half yearly audited accounts for the period have been filed up to the
(period ending 30.09.2017 and further period i.e. from 01.10.2017
18.09.2020 there are no transactions/ NIL receipts-and payments in
the company in liquidation, which are being filed along with this
application and may be taken on record.
- iv) dispense with the auditing of half yearly accounts as there are no
transactions for the period from 01-10-2017 to 18-09-2020.
- v) Dispense with the filing of final /annual accounts of the company in
view of filing of audited / unaudited (where there are NIL transactions
) half yearly accounts has been regularly filed upto 18-09-2020.
- vi) Order that M/s. Mekhanesoft Technonogies Pvt. Ltd. (In Liquidation)
be dissolved with effect from the date of the order.

- vii) Permit the Official Liquidator to dispose of / destroy the books of accounts and records of the company any day after expiry of 5 (five) years from the date of order of the dissolution of the company.
- viii) Permit the Official Liquidator to incur the costs of this application and other incidental expenses be met from and out of the Estate & Establishment Fund, since there are no funds available to the credit of the company in liquidation.

This Application coming on for orders upon reading the Judge's summons and the affidavit dated 29-09-2020 filed by Sri Pola Raghunath in support of the Application and upon hearing the arguments of Sri J. Srinadh Reddy, learned Counsel for the Official Liquidator on behalf of the Applicant and for the Respondent not appearing in person or represented by Advocate.

The Court made the following: ORDER

ORDER :

This Application is filed under Section 481 of the Companies Act, 1956 read with Rules 281, 282 & 9 of the Companies (Court) Rules, 1959 for dissolution of M/s. Mekhanesoft Technologies Private Limited, company in liquidation, and seeking the reliefs as set out in paras (i) to (viii). This Court, by order dated 14.07.2014, directed winding up of the company in liquidation.

Heard Sri J.Srinadh Reddy, learned counsel for the Official Liquidator and perused the statement of affairs of the company and also the affidavit filed by the Official Liquidator Sri P. Raghunadh.

As per the affidavit of the Official Liquidator, since there were no transactions in the company in liquidation, the requirement of conducting audit in terms of the Companies (Court) Rules, 1959 is dispensed with. As per the statement of affairs, no amounts are due to the workmen. As on date, there is no balance available to the credit of the company in liquidation. Further, no assets are available to be put for sale and no cases are pending as per the available records. In the circumstances, no useful purpose would be served in continuing the winding up proceedings without dissolving the company.

The Company Application is accordingly allowed.

Consequently, C.P.No.30 of 2013 is closed. The Official Liquidator shall forward the certified copy of this order to the Registrar of the Companies along with the statement signed by the Official Liquidator, as mandated under Rule 282 of the Companies (Court) Rules, 1959.

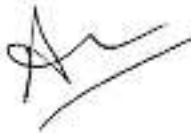
