The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and the order of the High Court dated 21.10.2020 made in CrI.P and upon hearing the arguments of Sri Venkat Rathnam Thanneeru Advocate for the Petitioner and of Public Prosecutor for the Respondent, the Court made the following

ORDER

This application is filed by the petitioner/A3 seeking to relax the condition imposed by this Court in the order dated 21.12.2020 in CrI.P.No.6348 of 2020 with regard to his appearance before the Station House Officer, III Town Police Station, Khammam every day between 10:00 AM and 5:00 PM till completion of investigation and filing of final report.

Heard both sides. Perused the record.

In the circumstances narrated, the condition imposed vide order dated 21.12.2020 with regard to appearance of the petitioner/A3 before the Station House Officer concerned is modified as follows:-

"The petitioner/A3 shall attend before the Station House Officer concerned once in fortnight i.e., Second and Fourth Saturdays of every month between 10.00 A.M. and 11.00 A.M. till filing of charge sheet."

The other conditions imposed in the said order remain unaltered.

The application is ordered, accordingly.
