In view of the reasons stated in the affidavit filed in support of the application, the condition imposed by this Court vide order dated 15.12.2020 in Crl.P.No.6620 of 2020, directing the petitioner/accused to appear before the Station House Officer, Khammam II Town Police Station, on everyday between 10.00 AM and 5.00 PM., till completion of investigation and filing of final report, is hereby modified directing the petitioner/accused to appear before the said Station House Officer on 1st and 3rd Saturday of every month instead of everyday till completion of investigation and filing of final report. The other conditions shall remain unaltered.

Accordingly, I.A., is ordered.
