ORDER:

This Revision is filed under Article 227 of the Constitution of India challenging the Docket Order dt.02.12.2020 in IA.No.553 of 2020 in OS.No.52 of 2020 of the XII Additional Chief Judge, City Civil Court, Secunderabad, issuing urgent notice to the respondent.

2. Counsel for the petitioner states that the matter is extremely urgent and that if the application for *ad-interim* injunction in IA.No.553 of 2020 is not considered, there is threat of dispossession of the petitioner by the respondent.

3. It is also informed that the lower Court, having issued urgent notice to the respondent on 02.12.2020 and directed the matter to be called on 09.12.2020, has subsequently on 09.12.2020 adjourned the matter to 18.01.2021.

4. In view of the urgency pleaded by the counsel for petitioner, the XII Additional Chief Judge, City Civil Court, Secunderabad, shall advance the hearing of the said IA.No.553 of 2020 in OS.No.52 of 2020, after giving notice to both sides, and consider the interim application IA.No.553 of 2020 on or before 07.01.2021, and decide whether in the circumstances an *ex parte ad-interim* order could be granted to the petitioner.

5. Accordingly, this Civil Revision Petition is disposed of. No order as to costs.

6. Consequently, miscellaneous petitions pending if any, shall stand closed.
