Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Order or Direction or Writ, particularly one in the nature of Writ of Mandamus declaring the action of the respondents in issuing memo vide C.No. 1/A2/26500/2015 dated 03/11/2015 thereby refusing to mutate the name of the petitioner in respect of house bearing Municipal No.13-1-155 and 13-1-156 (Old H.No.13/133), situated at Matwada, SVN Road, Warangal, despite her representations dated 16-10-2004 and also dated 20-08-2014 respectively submitted by her seeking mutation of her name as being illegal, unjust, unconstitutional, against procedures of law, against Municipal law and against principles of natural justice and to set-aside the same while consequently directing the respondents herein to mutate the name of the petitioner in respect of house bearing Municipal No.13-1-155 and 13-1-156 (Old H.No.13/133), situated at Matwada, SVN Road, Warangal, by following due process of law in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents herein to re-consider the representations dated 16-10-2004 and also dated 20-08-2014 respectively submitted by the Petitioner for mutating her name in respect of house bearing Municipal No.13-1-155 and 13-1-156 (Old H.No.13/ 133), situated at Matwada, SVN Road, Warangal, while suspending the impugned memo vide C.No.1/ A2/ 26500/ 2015 dated 03/ 11/ 2015, pending disposal of the above main Writ Petition in the interest of justice and to pass.
