Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus directing the respondents action disconnecting the supply of power the petitioner who is small farmer for the demanding half of the final assessment order No.DEA/HYD/DAT 137314 D.No.10052 dated 10-Feb-2015 amount of Rs.25,118/- and declaring the action of the respondent is illegal and not according to the terms and conditions of the supply where as in clause 9.3.5 it is authorized to collect only 1.5 times the normal rate levied for the petitioner.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed herein and upon hearing the arguments of Sri K.V. Upendra Gupta, Advocate for the Petitioner and Sri R. Vinod Reddy, learned Standing Counsel for the Respondents, the Court made the following
