The present criminal writ petition has been filed under Articles 226 and 227 of the Constitution read with Section 3(1) (a) of the Punjab Good Conduct Prisoners (Temporary Release) Act, 1988 for issuance of directions to the respondents to release the petitioner on parole for at least four weeks for attending the marriage of his real sister, which is to be solemnized on 09.02.2020.

Learned counsel for the petitioner contends that the petitioner had been convicted in FIR No.26 dated 04.03.2015, registered at Police Station Sirhind, under Sections 15 and 22 of the Narcotic Drugs and Psychotropic Substances Act, 1985. He further contends that the petitioner is the elder brother of Shilpa, who is got to be married on 09.02.2020 He

further contends that father of the petitioner expired on 05.01.2019 and now

there is no other male member in the family of the petitioner.

Learned State counsel submits that marriage of sister of petitioner is to be solemnized in Jhansi(UP) and has also produced a copy of communication signed by Mrs. Ram Kumari Yadav, Area Councilor, which had been received through whatsapp. The said communication is taken on record as Mark-A.

Heard.

Admittedly, the marriage of sister of the petitioner is to be solemnized on 09.02.2020. Taking into consideration the facts and circumstances of the present case, the Superintendent, New District Jail, Nahba, is directed to release the petitioner, who had been convicted in FIR No.26 dated 04.03.2015, registered at Police Station Sirhind, under Sections 15 and 22 of the Narcotic Drugs and Psychotropic Substances Act, 1985, on parole from 08.02.2020 to 14.02.2020 to attend the marriage of his sister, subject to his furnishing bonds to the satisfaction of the jail authorities.

The petitioner shall surrender at the gate of New District Jail, Nabha, on 14.02.2020 at 3.00 P.M.
