Affidavit of Respondent No.3 Ramphal endorsing alleged compromise in FIR in question with petitioner, has been filed. Same is taken on record. Be tagged at appropriate place.

Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing FIR No.178 dated 26.05.2018, registered under Sections 148, 307, 323, 506 read with Section 149 IPC and 25/54 of the Arms Act (report u/s 173 (8) Cr.P.C.), presented u/s 148, 149, 323 IPC qua the petitioner, at Police Station Madhuban, District Karnal.

Learned counsel for parties jointly submits that respondent No.2 is intentionally not coming forward just to blackmail the petitioner.

Perusal of order dated 12.12.2019 of a Coordinate Bench shows that respondent No.2 Ashish Sharma admitted to have signed the alleged compromise between the parties and now he is not coming forward to admit or deny the factum of compromise.

In view of above and the fact that the compromise will bring peace and harmony in relations between the parties, FIR No.178 dated 26.05.2018, and all subsequent proceedings arising therefrom on the basis of compromise, are quashed, subject to costs of ₹20,000/- as a pre-condition for quashing FIR on the basis of compromise, out of which petitioner shall deposited ₹10,000/- with the Poor Patients' Welfare Fund of the Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh and ₹10,000/- with the Welfare Centre for Persons with Speech and Hearing Impairment, Chandan Nagar, Sector 15, Phase-2, Behind ITI, Gurugram, Bank Account No.000434003000357, the Gurgaon Central Co-operative Bank Ltd. or Bank, Account No.1245010000518, United Bank of India. He can also opt to deposit the aforesaid amount of ₹10,000/- with the PGIMER online through its website "www.pgimer.edu.in".

Adjourned to 17.02.2020 for production of original receipts qua deposit of above costs.
