Prayer in this application is for placing on record the amended
petition.

Petitioner has approached this Court for grant of regular bail
by filing this petition under Section 439 of the Code of Criminal Procedure,

1973, in FIR No.214, dated 22.08.2019, registered at Police Station City Tarn Taran, under Sections 489, 489-A, 489-B and 489-C of the Indian Penal Code.

Counsel for the petitioner contends that the petitioner is in custody since 22.08.2019. He contends that the co-accused of the petitioner, namely, Lakhwinder Singh and Angrej Singh have been granted the benefit of regular bail by this Court on the ground that the report of F.S.L. has not yet been received. He states that the copies of these orders have been appended as Annexures P-2 and P-3 with the petition. Prayer has, thus, been made for the grant of regular bail on the ground that the petitioner is similarly placed as the co-accused.

Counsel for the State, on the other hand, asserts that the fake currency notes have been recovered from the petitioner, however, he could not dispute the fact that till date, the report of Forensic Science Laboratory has not been received.

Having considered the submissions of the counsel for the parties and keeping in view the fact that the petitioner is in custody since 22.08.2019 and his two co-accused have been granted regular bail by this Court as recorded above, which is apparent from the the orders placed on record as Annexures P-2 and P-3, this criminal miscellaneous petition is allowed and the petitioner is ordered to be released on bail subject to his furnishing bail and surety bonds to the satisfaction of the trial Court/Chief Judicial Magistrate/Duty Magistrate, Tarn Taran.

Any observation made herein-above shall have no bearing on
