CWP No. 7750 of 2020, CWP No. 7751 of 2020, CWP No. 7752 of 2020,
CWP No. 7753 of 2020, CWP No. 7754 of 2020 and CWP No. 7804 of 2020
as the issues involved in these petitions are common.

Mr. Akshay Bhan, Senior Advocate appearing on behalf of the
petitioners, while arguing the lead case i.e. CWP No. 7747 of 2020, has
submitted that the action taken by respondent No. 3 is without providing any
opportunity of hearing is patently illegal and against the principles of natural
justice.
