**AUGUSTINE GEORGE MASIH, J. (ORAL)**

Learned counsel for the petitioner contends that the petitioner was declared medically unfit due to substandard vision on 13.01.2020. Appeal was preferred by the petitioner, which was rejected vide communication dated 10.02.2020 (Annexure P-7). Petitioner thereafter got himself medically examined by the Civil Surgeon, Panipat, on 22.06.2020 (Annexure P-10). According to the medical report, the petitioner fulfills the criteria as has been laid down with as far as the requirement for vision for selection is concerned as per the substandard. Petitioner has submitted a representation dated 23.06.2020 (Annexure P-11) to the President, Central Airmen Selection Board, New Delhi-respondent No.3. The said representation of the petitioner has not been decided till date. Counsel has placed reliance upon order passed by this Court in similar matter i.e. *CWP No.7721 of 2020* titled as *Vikas Versus Union of India and others*, decided on 04.06.2020 (Annexure P-14), where directions have been issued by this Court to consider and decide the representation submitted by the petitioner therein in a time bound manner by passing a speaking order.

Counsel for the petitioner, on that basis, submits that the petitioner would be satisfied if a direction is issued in the present case also for consideration and decision upon the representation dated 23.06.2020 (Annexure P-11) as submitted by the petitioner.

Notice of motion.

Mr. Sunil Kumar Sharma, Senior Standing Counsel for Union of India puts in appearance on behalf of the respondents and states that he has no objection to the prayer made by the counsel for the petitioner for consideration and decision on the representation submitted by him to the President, Central Airmen Selection Board, New Delhi-respondent No.3.

Without going into the merit of the case or commenting thereon, the present petition is disposed of with a direction to the President, Central Airmen Selection Board, New Delhi-respondent No.3 to consider the request/submission made by the petitioner through representation dated 23.06.2020 (Annexure P-11) by passing a speaking order within a period of one month from the date of submission of the certified copy of the order. Decision so taken be conveyed to the petitioner forthwith.
