This appeal is filed under Section 19(1) of the Contempt of Courts Act, 1971 against the order dated 06.08.2020 passed by the learned Single Judge in COCP-1393-2020.

Shorn of unnecessary details, counsel for the parties have drawn the attention of this Court to an order dated 27.07.2020 passed in a bunch of writ petitions which read as under: -

*Learned counsel for the petitioners state that  
they have already supplied the information as per the  
performa but still the respondent/University is continuing to  
harass them and ask them to supply information, which is  
neither required nor permissible. It is further stated that  
they have no short coming.*

*Learned counsel for the respondent/University  
on the other hand while disputing the same submitted that  
the information is in accordance with law and they are  
bound to supply the same, which they have not done.*

*Taking into account the previous history qua  
the long dispute between the parties and keeping in mind  
the situation created by COVID-19, at this stage, it is  
directed as under:-*

*a) The respondent/University will declare the result of  
examination held in December, 2019, if already not  
declared and in case the examination has been held, as  
required.*

*b) The respondent/University shall also grant the provisional affiliation, which will be subject to outcome of the present writ petitions. Meanwhile, the petitioners too shall not stand on any ego problem and supply the information as demanded by the University to enable them to pass the final order on the said affiliation for the year 2020-2021.*

Counsel for the appellants has submitted that the respondents have not supplied the documents required in terms of letter dated 11.5.2020 (Annexure A-1) as well as the affidavit for the purpose of grant of provisional affiliation.

Counsel for the appellants has submitted that the necessary order shall be passed by 20.8.2020 for grant of provisional affiliation after receiving the required documents by the respondents through email.

In view thereof, the present appeal is hereby disposed of.
