The petitioner is seeking anticipatory bail in FIR No. 219 dated 14.08.2020, under Section 420 of the Indian Penal Code, 1860, registered at Police Station City Sunam, District Sangrur.

Learned counsel for the petitioner contends that it is alleged in the FIR that the petitioner had borrowed a sum of ₹2,50,000/- from the complainant and later on in return thereof had issued a cheque for the same amount in favour of the complainant which was dishonoured. He also contends that the complainant has not filed any complaint under the Negotiable Instruments Act, 1881 ('NI Act' - for short). He further contends that the petitioner is 20 years of age and is not involved in any other criminal case.

Issue notice to the respondent.

At the asking of the Court, Mr. Dhruv Dayal, Senior DAG, Punjab, accepts notice on behalf of the respondent. He contends that in view

of the gravity of the offence alleged to have been committed by the petitioner, he is not entitled to the concession of anticipatory bail.

Without expressing any opinion on the merits of the case and in view of the submissions of learned counsel for the petitioner, I deem it a fit case to grant the concession of anticipatory bail to the petitioner.

Therefore, the petitioner is directed to appear before the investigating officer within a period of 15 days from the date of receipt of certified copy of this order and on his doing so, he shall be released on bail to the satisfaction of the arresting/investigating officer till submission of report under Section 173 of the Code of Criminal Procedure, 1973 ('Cr.P.C.' - for short). The petitioner shall continue to join investigation and shall furnish an undertaking that he shall abide by the conditions as envisaged under Section 438 (2) Cr.P.C. Thereafter, he will be permitted to furnish regular bail bonds to the satisfaction of the trial Court.

The petition stands disposed of in the aforementioned terms.
