1. Case is being taken up for hearing through Video Conferencing due to the outbreak of pandemic Covid-19.

2. Prayer in the Criminal Writ Petition under Article 226 of the Constitution of India is for the issuance of a writ in the nature of Mandamus for directing respondent Nos.2 and 3 to protect the life and liberty of the petitioners at the hands of respondent Nos.4 to 7 as also not to interfere in the matrimonial life of the petitioners at the behest of respondent Nos.4 to 7.

3. Learned counsel contends that petitioner No.1 is 25 years of age as is evident from Aadhaar Card, Annexure P/1, as per which her date of birth is recorded of the year 1995, while petitioner No.2 is also about 25 years of age as is evident from Aadhaar Card, Annexure P/2, where his date of birth is recorded as 21.10.1995, that the petitioners fulfill all the conditions stipulated under law to entitle them to get married and on account of mutual liking the petitioners got married on 20.09.2020 as is evident from marriage certificate, Annexure P/3 dated 20.09.2020 though against the wishes of respondent Nos.4 to 7 who are threatening them with harm to their life and liberty. Learned counsel contends that the petitioners have submitted representation Annexure

P/4 dated 20.09.2020 to respondent No.2 i.e. Senior Superintendent of Police, SBS Nagar, for redressal of their grievance but no action has been taken in respect thereto till date and that in the circumstances, the petitioners would be satisfied if the writ petition is disposed of by directing respondent No.2 to consider and decide the representation Annexure P/4 dated 20.09.2020, in accordance with law, in a time bound manner.

4. Notice of motion to respondent No.2 only.

5. Mr. Amar Ashok Pathak, Addl. AG, Punjab, accepts notice on behalf of respondent No.2 and states that he has no objection to the limited prayer made by learned counsel for the petitioners.

6. Accordingly, in view of the decision of Hon'ble the Supreme Court in **Lata Singh vs. State of UP and others, JT 2006 (6) SC, 173**, but without commenting upon the age of the petitioners, validity of their marriage or the authenticity of the documents attached with the writ petition, the writ petition is disposed of by directing respondent No.2 i.e. Senior Superintendent of Police, SBS Nagar, to consider and decide representation, Annexure P/4 dated 20.09.2020, submitted by the petitioners as expeditiously as possible and to take such action in respect thereto in accordance with law as may be warranted keeping in view the threat perception to the petitioners. However, it is made clear that this order shall not bar any civil or criminal proceedings initiated against the petitioners in accordance with law.
