The petitioner has approached this Court Articles 226/227 of the Constitution of India, *inter alia*, seeking quashing of the action of the respondent Commission for not calling the petitioner for interview for the post of PTI in BC-A category, pursuant to the advertisement No.6/2006, dated 20.07.2006 (Annexure P-1) Category No.23, which are scheduled for 01.10.2020, 03.10.2020 and 04.10.2020, as per notice dated 24th September, 2020 (Annexure P-11), despite the fact that candidates equal to three times of the advertised posts in the respective categories, had to be mandatorily called. Besides, a prayer has also been made for directing the respondents to interview the petitioner for the post of PTI in BC-A category, subject to the final outcome of the instant petition.

Notice of motion.

On the asking of the Court, Mr. P.K. Longia, DAG, Haryana, accepts notice on behalf of the respondent. Copy of the paper book has already been supplied to the respondent in advance.

After arguing for some time, learned counsel for the petitioner

submits that he would be satisfied if the instant petition is disposed off with

a direction to the respondent Commission to look into the objections submitted by petitioner on the official web portal of the respondent Commission (Annexure P-8) and take appropriate action, if any required, in accordance with law, with respect to the questions which were found to be incorrect, but which as per the petitioner have been correctly answered. He further submits that the petitioner has secured 80 marks and would become eligible to be interviewed, in case the objections *qua* her answers, which have been submitted by her on the official web portal of the respondent Commission are found to be correct.

In the circumstances and keeping in view the limited prayer made by the petitioner, the respondent Commission is directed to look into the objections (Annexure P-8) submitted by the petitioner on its official web portal and decide the same expeditiously before 04.10.2020 and in case, the petitioner is found eligible by the respondent Commission as per the criteria fixed, then she be called for the interview on 04.10.2020.

The instant petition stands disposed off in above terms.
