In view of the reasons mentioned in the application, the same is allowed and the hearing of the main petition is preponed from 31.1.2021 and the same is taken on board today.

**CRM-30275-2020**

In view of the reasons stated in the application, the same is allowed and the compromise Annexure P-6 is ordered to be taken on record subject to all just exceptions.

**CRM-M-31181-2020**

1. The petitioner has approached this Court seeking grant of regular bail in respect of a case registered vide FIR No.458 dated 10.06.2020 at Police Station Model Town, Panipat, under Sections

148, 149, 323, 324, 452, 506 IPC (Sections 325, 326 IPC added later on).

2. The learned counsel for the petitioner has submitted that it is a case where another FIR i.e. FIR No.451 dated 06.06.2020 under Sections 323, 506, 34 IPC was lodged against the opposite party about 5 days prior to lodging of the instant FIR and that as per compromise Annexure P-6, the matter now stands amicably resolved amongst the parties, who are residents of the same village.
3. Mr. Lajpat Sharma, Advocate, has put in appearance on behalf of the complainant and has endorsed the factum of compromise amongst the parties.
4. The learned State counsel has informed that the petitioner has been behind bars since the last about 3½ months and that challan already stands presented.
5. Having regard to the aforestated position, where challan already stands presented and the matter is stated to have been compromised, the petition is accepted and the petitioner is ordered to be released on regular bail on his furnishing bail bonds/surety bonds to the satisfaction of learned trial Court/Chief Judicial Magistrate/Duty Magistrate concerned.
