GIRISH AGNIHOTRI, J. (ORAL)

Present petition has been filed by the petitioners-Kulwant Singh and 07 others, *inter alia*, with the prayer to quash the seniority list and also to correct the revised seniority list of the Head Constables and with further direction to place the name of the petitioners at appropriate place in the revised seniority list.

Records of the case show that notice of motion in this case was issued on 16.05.2017. Thereafter, Sh. Opinderjit Singh, PPS, Senior Superintendent of Police, Batala, Police District Batala, has filed the reply dated 09.01.2019 on behalf of respondents No.1 to 7. In para No. 2 of the reply, it has been submitted that common seniority list upto 20.02.2008 has been issued by the Director General of Police, Punjab Chandigarh, on 10.11.2017. It has been further stated that the petitioners have been granted revised date of promotion as Head Constable as mentioned against their names. It is further submitted that in view of the above, the petition has

been rendered infructuous and be disposed of as such. Para 2 of the reply is reproduced hereunder:-

“2. That it is respectfully submitted that common seniority list of PAP and District Police Upto 20-02-2008 has been issued by the Director General of Police, Punjab Chandigarh vide letter No.12108-12208/E-1(5) dated 10-11-2017 in compliance with judgment dated 06.12.2014 passed by the Hon'ble High Court CWP No.4829 of 2011 SI Pardeep Singh and Others Vs. State of Punjab. The petitioners have been granted revised date of promotion on Head Constable as mentioned against their names:-
